When a family registers for Scouting, they will have the choice to pay up-front from the time of joining through the end of the calendar year *or* to pay a smaller joining fee up-front and subscribe to monthly payments for the remaining balance. Please note that there may be additional unit fees. Please check with your unit leader about any additional costs. The Scout Handbook is one time only upon joining. There are two options for the Membership Package:

#### A) Monthly Subscription Option

With the Monthly Subscription Option, monthly charges will continue until the family opts out with a 30 day notice. Monthly payments will start the month after registration and will occur on or around the 15th.

Sign-up Month	Due at registration	Monthly Payment*
Jan - Jul	\$15	\$15 (plus any Unit Dues if applicable)
Aug - Dec	\$50	\$15 (plus any Unit Dues if applicable)

#### B) Upfront Payment Option

With the Upfront Payment Option, the above fees cover the 2022 calendar year. There will be 2023 fees due in November of \$147 plus any Unit Dues (if applicable).

Sign-up Month	Due at registration*
Jan - Mar	\$140 (plus any Unit Dues if applicable)
Apr - Jul	\$115 (plus any Unit Dues if applicable)
Aug - Oct	\$90 (plus any Unit Dues if applicable)
Nov - Dec	\$65 (plus any Unit Dues if applicable)

\* Unit dues (if any) will not be paid at time of registration. Please see your unit leader to find out how much (if any) unit dues are. Most units will provide fundraising opportunities (popcorn and camp cards) to help offset costs and thus most unit dues are either none or small amounts.
