<input type="checkbox"/>	A) All adult apps sign by CR & Committee Chair
<input type="checkbox"/>	B) All youth applications signed by Unit Leader/Designee
<input type="checkbox"/>	Ensure all NEW adult applicants have completed their Criminal Background Check (CBC) authorization form on application and have current Youth Protection Training
<input type="checkbox"/>	Complete UNIT Final Recharter Checklist and attach to a copy of your printed charter
<input type="checkbox"/>	Charter Review at District Level by District Commissioner or Council Employee.
